

## Imports Dragon Contest Rules

### “PARTICIPATE TO GET A CHANCE TO WIN A FREE GIFT BASKET OF TOY”

#### 1. Contest period

. 1.1 Registration for the contest is from October 1<sup>st</sup>, 2016 at 9:00am to September 30<sup>th</sup>, 2018 at 11:59pm.

. 1.2 A draw will take place at 2515 avenue De la Renaissance, Boisbriand (Québec), J7H 1T9, the last day of every three months, at 1:00 pm, for the contest duration.

#### 2. Method of Entry

. 2.1 **No purchase required.** To enter the “PARTICIPATE TO GET A CHANCE TO WIN A FREE BASKET OF TOY”, all participants must be on legal age to participate to a contest in their province of contest completion and must complete an entry form online via the website [www.importsdragoncontest.com](http://www.importsdragoncontest.com) or on the Imports Dragon Facebook page.

. 2.2 Once you obtain the entry form, follow the directions on the screen in order to: (i) Choose your preferred language, enter your full name, a valid email address, full home address, phone number, date of birth, your gender and since it's a contest for kids under 12 years old, we will ask the question: How many kids you have under 12 years old and what gender and age are they; (ii) Consent to be legally bound by the terms of the present official rules, Once the entry form is complete, all the necessary information registered and acceptance of the rules given, press on “Submit” to complete you entry (the “entry”). You will receive an email confirming your subscription to the contest.

**3. Conditions of Participation** . 3.1 Only Canadians residents with majority age in your province or over are eligible to participate.

. 3.2 The employees, directors and officers of Imports Dragon, its subsidiaries, parent corporations, promotional and advertising agencies, and members of the comity liable for the draw, as well as their immediate family (parents, siblings, children and spouse) and members of the same household are unauthorized to participate to this contest.

The content of the gift baskets may vary.

Without limiting the generality of the foregoing, the price is subject to the following general conditions:
